Compliance with statutory regulations on occupational health and safety, such as the German Workplace Ordinance (ArbStättV), the German Ordinance on Hazardous Substances (GefStoffV), accident prevention regulations, as well as environmental conservation regulations, such as the German Waste Management Act (AbfG) and the German Water Management Act (WHG), obliges all commercial companies to protect their employees, other people and the environment from any harmful impact when handling hazardous substances.

Please be aware that pumps or liquid meters that have come into contact with toxic, explosive, microbiological, radioactive or other substances, harmful to health, must be decontaminated in accordance with the regulations before they can be returned.

To prevent our employees who are responsible for handling (receipt of goods) and maintenance and repair of the pumps/liquid meters being exposed to any hazard, it is imperative that you inform us with which liquids the pumps/liquid meters have come into contact.

We would therefore request that you provide us with a decontamination certificate stating that the parts have been cleaned and adequately rinsed with a neutral liquid prior to despatch when returning a pump/liquid meter for repair.

Pumps that have been operated in radioactively contaminated liquids cannot be accepted for maintenance or repair.

Should safety precautions nevertheless be necessary in spite of careful decontamination of the pump/liquid meter, then you must provide us with the necessary information before returning the unit.

We reserve the right to return unrepaired any pumps that we receive without certification.
